#### **CR ALDEN'S REPORT**

"This past month over the Christmas break has seen less community activities to speak about in my report and more of the internal work with Council's committees and working groups. One of these, the preparation for the City's bid to UNESCO to become an accredited Creative City of Gastronomy, is progressing well.

To date we have launched the concept, established two working groups, both internally and externally focused and benefitted from my travel to Italy to discuss cities of gastronomy and their experiences regarding the process of accreditation and the subsequent benefits for their communities. The City of Parma combines food, culture, art and music and the city of Alba has developed many joint projects, leveraging their significant tourism status to advantage. The City of Bologna oversees the Creative Cities Network for Italy and their Office of Civic Imagination has just won an Engaged Cities award, much of it relating to their UNESCO status and associated activities.

The Internal working group for this project crosses many areas of council business: Health and Wellbeing, Tourism, Economic development, Environment, Cultural heritage, Creative industries and more.

The external advisory committee was advertised publicly and comprises some 20 members drawn from primary producers, chefs, winemakers, manufacturers, educators, academics, food relief agencies and representatives from farmers' markets, small producer networks and community gardens.

Using this project as a driver for action, we can progress many opportunities to address some of our city's challenges around health and sustainability in particular as we plan for the future.

Our application will celebrate our diverse and thriving food scene, our Aboriginal food heritage and culture, our healthy food initiatives and our innovation and creativity across Greater Bendigo and the region.

"We have a strong food heritage, such as tomato growing, and a tradition of agrarian life, which still informs our culture. Innovations in agriculture that extend beyond our Traditional Owners include; inventing the first world's first commercially successful combine harvester, constructing large scale irrigation systems, and adapting plants and crops to different climates and soils. Innovation is central to the success of our diverse food and beverage production and to our producers.

A shout out to those in particular with knowledge around Bendigo's tomato heritage as I am compiling some tomato-related history that hopefully will be displayed at the Maiden Gully Autumn Festival in April. I look forward to hearing from you.

Greater Bendigo's food and beverage scene is diverse and growing, with the gastronomy industry worth \$1.6 B in 2017. Jobs in the food industry have experienced greater levels of growth than the rest of the economy, increasing by 26% between 2011 and 2017. In 2016 46% of manufacturing employment in Greater Bendigo was in food manufacturing.

Across the region food brings people together and helps build skills and resilience. Refugee and migrant communities, school and university students and vulnerable groups are engaged with projects around food, gardening, cooking and the rehabilitation of the natural environment.

Heritage market gardens at PepperGreen Farm have been transformed into a hub for fresh produce, art and cultural activities. The Bendigo Regional Food Alliance's Cooking Clubs project is commencing with local partner agencies for food literacy and food security in disadvantaged communities, Food Fossickers (food industry) Network, Bendigo Food Share, Castlemaine's Growing Abundance, Harcourt Valley growers cooperative, craft beer and cider makers, winemakers associations, food retailers, moonlight market and farmers market, community and school gardens and more - just some of what makes up the rich and creative gastronomic activities in our region.

We celebrate our multicultural music, food and art with the Zinda Festival, aimed at local, national and international audiences, highlighting the role of creativity and food in breaking down cultural barriers. Then there is the Bendigo Writers Festival including a Gastronomy program, bringing together people from all disciplines to consider the intersections of food, drinks, agriculture, culture and writing.

The Bendigo Easter Festival is the longest running community cultural festival in Australia – first held in 1879, the spring Agricultural Show and other events held throughout the year are also help to grow the food and drinks sector of the economy - Melbourne Food and Wine Festival's 'Longest Lunch' event, the Food Truck Festival, Bendigo On the Hop craft beer and cider festival, Wine and music Festivals and numerous other food-focused celebrations are aimed at promoting our producers and creators.

We have a firm basis for gastronomic tourism through Council's award winning Bendigo Tourism Information Centre, with popular events such as From market to paddock to plate tours and Food Fossickers local food business tours for example.

So what's coming up this year? We are working hard on our networks of activity and mapping and liaising with many, many initiatives and groups in the region. In a couple of months the guidelines for the application will be announced by UNESCO and we can fine tune our draft application for testing and feedback. By July we will be ready to submit to UNESCO and by November, hear the outcome of our application.

"At the very least we will have progressed all of the food related activities under the region's banner. At best will have a major initiative as a UNESCO Creative City of Gastronomy that will create fantastic opportunities for our city and region. A further drawcard for food related activities, and with that jobs and investment and multiple benefits for our broader community".

- (h) conflicting personal interest

A Councillor who has declared a conflict of interest, must leave the meeting and remain outside the room while the matter is being considered, or any vote is taken.

Councillors are also encouraged to declare circumstances where there may be a perceived conflict of interest.

Cr O'Rourke declared a conflict of interest (direct financial interest in the item of Urgent Business, Report No. 8.1 (Visit to Hong Kong [February 2019]) as she is the nominated Councillor to attend the delegation to Hong Kong).

The following petition has been received from residents in Hasker Drive, Kangaroo Flat requesting the removal of gum trees:

"We are petitioning for the removal of said gum trees, considering them to be a fire hazard.

This drive/street is mostly made up of older citizens who will be stressed about the amount of mess that comes from gum trees being to close to residences.

We do not understand why our council would allow gums to be lining our streets. It we lived on a farm, we would never plant gum trees so close to our hoses because of the obvious fire risk. This would also be the advice we would get from the fire services. So why would council put our lives and homes at risk of fire.

We are hoping that someone will listen to us. We have moved to this lovely new estate and really do not want to spend the rest of our lives cleaning gutters, paths and gardens from the mess the gums will make. Not to mention the worry that comes with gums and fire.

As the rate payers of these properties we feel we should have some say about the trees placed in front of our homes.

We have built low maintenance properties because for the majority of us, our age. Now we have high maintenance trees in terms of clean up and fire danger.

We sincerely hope that we will be heard and common sense will prevail".

#### **Background Information**

The Youth Council's role is to represent the voice of young people aged 14 to 24 who live, work and study in the Greater Bendigo municipality. It will act as an advisory and advocacy body to Council.

Expressions of Interest (EoI) for the Youth Council were publicly sought through advertisements and / or articles in newspapers and community newsletters, the City of Greater Bendigo and YO Bendigo websites and social media platforms, as well as relevant email networks.

Eols opened on November 1 and closed on December 3, 2018.

#### Previous Council Decision(s) Date(s):

December 13, 2017 - Council adopted the Youth Strategy - Explore, Engage, Empower: Young People in Greater Bendigo (2017- 2021).

### Report

47 EoIs were received in total.

The Eol process required applicants to respond to four questions. These questions sought information from applicants about relevant knowledge, skills and previous experience in community leadership.

All Eols received were assessed and shortlisted by the following four Council officers:

- Leon Moulden (Community Partnerships Project Officer)
- Rory White (Inclusive Communities Officer)
- Gemma Simpson (Inclusive Communities Officer)
- Megan Goode (Inclusive Communities Officer)

The Council officers assessed all applicants against the following criteria:

- Motivation to nominate.
- Understanding of young people's needs in our community.
- · Understanding of the role of a youth councillor.
- Experience in community leadership.

As an outcome of this process, 25 applicants were shortlisted for interview.

Due to the volume of shortlisted applicants, the interviews were carried out over three separate sessions. The Councillors and Council officers who participated in the interview process were:

# 8.1 VISIT TO HONG KONG (FEBRUARY 2019)

#### **Purpose**

The purpose of this report is to endorse a brief trip to Hong Kong in February 2019 by the Mayor to represent the City of Greater Bendigo at the blessing of Bendigo's new Chinese imperial dragon Dai Gum Loong.

The proposal has the support of the Bendigo Chinese Association both culturally and in building relations between Bendigo and Hong Kong.

#### Summary

Dai Gum Loong is nearing completion in Hong Kong under the careful direction of Master Hui - a third generation dragon maker.

A ceremony in Hong Kong on Saturday 2 February including a traditional blessing of the dragon to prepare it for its journey to Bendigo and will complete the dragon-making process.

Cr O'Rourke declared a conflict of interest (direct financial interest in the item of Urgent Business, Report No. 8.1 (Visit to Hong Kong [February 2019]) as she is the nominated Councillor to attend the delegation to Hong Kong.

Cr O'Rourke left the meeting.

In the absence of the Chair, the Deputy Mayor, Cr Fyffe, assumed the Chair.

#### **Report and Background Information**

In 2018 the Golden Dragon Museum and the City of Greater Bendigo signed a special contract with dragon maker – Master Hui – to build a new dragon to be known as Dai Gum Loong.

The traditional ceremonies on 2 February will mark the blessing of the dragon for its journey to Bendigo.

Representatives of the Bendigo Chinese Association (BCA) and Golden Dragon Museum will also be in attendance.

The Mayor's attendance at the ceremony is strongly supported by the BCA.

Council has been advised that from a cultural perspective the Mayor's attendance on behalf of the Greater Bendigo community is important and would be seen as significant by relevant parties in helping to build relations between Bendigo and Hong Kong.

Dai Gum Loong is part of a \$750,000 project which also includes conservation work for Sun Loong. Greater Bendigo City Council contributed \$100,000 towards the project with the balance coming from the Federal and State Governments and public contributions.

Dai Gum Loong has been under construction for 10 months. He has approximately 6,500 scales and is more than 100m long, making him the longest dragon of his kind in the world and surpassing his predecessor Sun Loong.

He will be completed in time for Easter 2019.

Dai Gum Loong will be Bendigo's third imperial dragon. Bendigo Golden Dragon Museum's first dragon, Loong, was brought to Victoria by the Bendigo Chinese Association in 1892 and was replaced in 1970 with Sun Loong, 'the New Dragon'.

Dai Gum Loong has been constructed in the same style as his predecessors.

Virgin Australia has undertaken to fly Dai Gum Loong to Australia once he is built.

Whilst partly funded by Council the Bendigo Chinese Association will be the cultural custodian of Dai Gum Loong and he will be on display at the Golden Dragon Museum when not parading.

Dai Gum Loong is expected to be in Australia in time to take part in the Bendigo Easter Festival Gala Parade alongside Sun Loong and Loong. It will be the first time all three dragons will appear in public together.

#### **Resource Implications**

The cost of the trip will be approximately \$2,000 which can be accommodated within the current budget.

Cr Metcalf conveyed congratulations to Eaglehawk's Citizen and Young Citizen of the Year, Brian Bourke and Amy Croft as well as the City of Greater Bendigo Citizen and Young Citizen of the Year, Kevin Cail and Sam Kane.

Cr Flack reported on the celebration of Christmas and was proud to 'MC' the Community Christmas lunch on Christmas Day at the All Seasons with 240-250 people in attendance including Crs O'Rourke and Fyffe and a number of volunteers from all areas, including Council staff.

Unfortunately, both the Heathcote and Eaglehawk Carols were washed out, so the contribution of the involvement of the Marist Brass Band of which I am a member was also cancelled.

Cr Flack advised that after having a refreshing break over the Christmas/New Year period, it is back into the meeting cycle!

Cr Flack highlighted the cultural importance of the City's new Imperial Dragon, Dai Gum Loong with approximately ten (1) dragons 'coming out to play' at this year's Easter procession.

Cr Pethybridge highlighted his visit to the tram depot in early December with the Mayor and Deputy Mayor to witness the first rollout of Tram 961 to be handed over to Melbourne; this will run on the Melbourne loop - Bendigo Tramways recondition trams for all over Australia, including Tram 961 for Melbourne (this came out looking better, in my opinion, than new ones!) - this is a credit to Bendigo Tramways to reproduce the trams of this calibre.
