#### 1 | Exceptional Circumstances

You have committed the offence due to unforeseen or unpreventable circumstances, e.g. an unforeseeable medical emergency, you entered the wrong information into the meter, forgot to display your ticket, were unable to renew your animal registration due to illness or a third party let your dog out of your yard

#### 2 Contrary to Law

You believe the decision to issue you with an infringement was unlawful or you did not commit an offence.

#### 3 3. Special Circumstances

You were unable to understand that your behaviour constituted an offence or were unable to control your behaviour due to:

- Mental or intellectual disability, disorder, disease or illness or
- A serious addiction to drugs, alcohol or volatile substance or
- Homelessness or
- Family violence within the meaning of the Family Violence Protection Act 2008

For a special circumstances application to be considered you must provide evidence such as a letter, report or statement from one of the following parties to support your application:

- A case worker, case manager or social worker
- A general practitioner, psychiatrist or psychologist, or
- An accredited drug treatment agency

Evidence from one of the above should include the following information:

- The practitioner/case worker's qualification and relationship with you, including the period of engagement.
- The nature, severity and duration of your condition or circumstances including:
  - a. Whether you were suffering from the relevant condition or circumstances at the time the offence was committed and;
  - b. Whether, in the opinion of the practitioner/case worker, there is a connection between your condition/circumstances and your inability to understand or control the conduct constituting the offence.

#### 4 Mistaken Identity

You believe someone else committed an offence and the infringement was mistakenly issued to you instead of them. This may include instances where you believe the infringement was issued to a vehicle with the wrong registration or due to an animal which does not belong to you. Please provide an explanation of why you are applying on the grounds of mistake of identity and include supporting evidence such as a copy of your:

• Driver's licence, Birth certificate, Passport

You should also provide evidence indicating you could not have committed the offence as you could not have been in the relevant location at the time in question.

This ground is not available where a parking infringement has been issued and you were not the driver. In this instance the owner is responsible for the infringement unless the driver of the vehicle is nominated by providing the driver's full name, residential and postal address in a signed statutory declaration or by using the City of Greater Bendigo's Known User Statement.

#### 5 Person Unaware of Fine

This option is available where you were unaware the infringement had been issued to you and you have received a reminder notice including additional costs. A person unaware of fine application only relates to the removal of the additional late fees.

In order to be considered, an application made under the grounds of 'person unaware' must:

- Be made within 14 days of you becoming aware of the infringement notice
- State the reasons you believe the infringement should be reviewed (what you believe contributed to you not knowing about the infringement notice, i.e. you were overseas or had moved house)
- Provide your current address for service
- Supply evidence to support your application, such as airline tickets, receipts for accommodation, tenancy agreement or a statutory declaration.
